- b. Solar Panels: The solar panel system (original system) installed as part of the 2003 Geyserville Fire Station construction has failed. The solar panels and system that were added later remain operational. This is a request to authorize the expenditure of up to \$10,000 to repair the original solar system at the Geyserville Fire Station.
- c. Wildland Firefighting Positions SOP: Presentation and discussion of the Wildland Firefighting Positions SOP.
- d. Fuels Manual: Request for expenditures associated with legal review of Wildland Fuels Mitigation Employment Manual. Review is expected to take 10-15 hours at \$240 to \$380 per hour.
