- a. Strategic Planning Updates: Report plan updates and progress.
- b. Update on City and Service Zone Outreach Efforts: Board members and Chief will report on any meetings or contacts during the past month and plans for upcoming meetings.
- c. Consideration of Approval to Create a District-Wide Service Zone: The Board will consider approval to create a Service Zone to make vegetation management a responsibility of the Northern Sonoma County Fire Protection District.

Vineyard View Statement of Support: Review presentation by representatives of Vineyard Valley View Property Owners and request for Board statement of support for comment letter to be submitted to the State Fire Marshal and other public officials regarding the proposed revisions to the Fire Hazard Severity Zone Designations. The comment letter addresses community concerns over possible adverse effects of the designations, including on the availability and cost of property insurance.
