#### 12. OLD BUSINESS:

- a. Consolidation and Annexation: Discussion and exploration of possible future annexations and consolidations with neighboring fire departments and corresponding tax agreements.
- b. Employee Retirement: Update on the current JPA with Cloverdale and our three captains' employment with Cloverdale. This includes discussion of the three firefighters hired last year and their retirement.
- c. Alexander Valley Fire Station: Discussion and updates on the pursuit of money from MAC for the maintenance of the Alexander Valley Fire Station.
- d. (Proposed) Chalk Hill Fire Station: The District is currently looking for a site to build a fire station to better serve the Chalk Hill area. Updates will be given on the search for a new location and suggestions for sites to explore.
- e. Knights Valley Lease: Ongoing discussion regarding a new lease with the Knights Valley Volunteer Fire 501c3 for the use of the Knights Valley fire station.

- f. 457 Administration Fees: The District has been paying 457 plan management fees for all employees with 457 accounts.
- g. Admin Title and Benefits: The Board will be discussing benefits for the Administrative Manager position.

#### 13. NEW BUSINESS:

- a. Portal to Portal Resolution: This resolution is an update to a previous portal to portal resolution. Cal OES needs the resolution to be made by the Northern Sonoma County Fire Protection District.
- b. SOPA-37 Vegetation Management Positions: This resolution addresses the job positions within the vegetation management program of the District.
- c. SOPA-15 Volunteer Fire Suppression Personnel: Last July, this resolution was mistakenly adopted as SOPA-4 instead of SOPA-15. This resolution replaces SOPA-15 Volunteer Firefighters.
- d. Fiscal Year 2020/2021 Budget: Discuss plans to prepare the preliminary budget for the fiscal year 2020/2021, which needs to be adopted by June 30, 2020.
- e. Wages/salaries for FY 20/21: The MOU is expired and does not includes wages for next year. Create a subcommittee to discuss wages and salaries for the three temporary firefighters, the Chief, and the Administrative Manager.
- **14. GOOD OF THE ORDER:** This time is set aside for comments from the Board members and the public regarding general interest such as special events, parties, announcements, fundraisers, etc.
